- 1. I am the Founder and President of A Voice For Choice, Inc., A California Not-For Profit Corporation, and a current Plaintiff in the matter entitled Love v. State of California, *Case No.:* 5:16-cv-2410, as filed in the United States District Court, Central District of California, Eastern District (the "Matter"). I have personal knowledge of all matters and facts set forth herein and could and would competently testify thereto if called upon to do so.
- 2. A Voice For Choice, Inc. ("AVFC") was formed as a Not-For Profit Corporation with the California Secretary of State on December 1, 2015.
- 3. One of the primary stated purposes of AVFC is to educate and protect the rights of individuals and ensure that the general public has knowledge of and a choice in what medications are put into the bodies of their children and themselves.
- 4. To date, AVFC has approximately Four Hundred and Fifty (450) members.
- 5. A significant number of AVFC's membership includes individuals who question the constitutionality of the decree that is CA Senate Bill 277, and the subsequent CA Health & Safety Codes, namely Section 120325, *et seq.* ("Section 120325") and what right any governmental or legislative body has to mandate that an individual forego one fundamental right for another. Moreover, the general membership of AVFC is comprised, in part, of individuals that are California citizens who have school aged children that are not fully vaccinated in accord with the requirements of Section 120325, and desire to exercise their fundamental right to parent, as well as their right to bodily autonomy, to refuse medical treatments, and for their children to receive a public-school education, as specifically afforded by and through California's Constitution.
- 6. The members of AVFC are individuals who are and continue to be equally harmed as a result of the ongoing enforcement of Section 120325 and
